Meeting Memorandum for the WeGO Executive Committee Meeting 2016

October 12, 2016 / Beyoğlu, Turkey

As a review for members who attended, and for members who did not, here is a brief report from EXCOM 2016

Meeting Participants

Executive Committee Members (8): Agra (India), Chengdu (China), Hebron (Palestine), Khartoum State (Sudan), Maputo (Mozambique), Seoul (Korea), Ulyanovsk Region (Russia).

Observer Institutions (2): National Information Technology Development Agency (Nigeria), Uraia

Agenda 1: Annual Assessment of the WeGO Regional Offices

The Executive Committee conducted the annual assessment of the WeGO Asia Regional Office, Chengdu and the WeGO Europe Regional Office, Ulyanovsk Region and **unanimously approved continuation of their operations.** After the Regional Offices had presented their annual reports, the WeGO Secretariat assessed both Regional Offices' overall performance for the past year as satisfactory mentioning the Ulyanovsk Region's strong commitment for hosting the 4th WeGO General Assembly in 2017 as well as positive experience of collaboration with Chengdu as the host of the previous GA.

Agenda 2: New Memberships to Date

The Executive Committee 2016 **approved 18 New Cities and 2 Friendship members**, who joined since the Executive Committee Meeting 2015 in Ulyanovsk Region, Russia.

Agenda 3: Dates, Themes, and the Tentative Program for the 4th WeGO General Assembly 2017

Following a special request from the President City Seoul to the Ulyanovsk Region, the months of September and October initially indicated by the Ulyanovsk Region as the preferred timeframe for hosting the General Assembly was moved up to the month of June.

The WeGO Secretariat and the Ulyanovsk Region initially suggested to the Executive Committee the dates for holding the 4th WeGO General Assembly 2017 on June 20-23. However, the Executive Committee pre-approved **the dates between June 20 and 30** in consideration of Ramadan and the WeGO Secretariat, taking into account the holidays, formally announced the final dates (June 27-30) to all WeGO members upon consultation with the leadership of President City Seoul and the host Ulyanovsk Region after the completion of the WeGO Executive Committee Meeting 2016, nearly eight (8) months in advance.

Agenda 4: Updated WeGO Mission and a Broad Outline of the Three-Year Strategic Plan

The Executive Committee reviewed the first proposal for the updated WeGO Mission and Three-Year Strategic Plan as well as comments previously provided by the special Advisory Committee and WeGO partners. During the session, the Executive Committee and observers additionally provided feedback.

Agenda 5: Amendments to the Terms and Conditions of the WeGO Awards

The Executive Committee reviewed and **adopted the new amendments to the Terms and Conditions of the WeGO Awards**, as proposed. The modifications mainly apply to 1) the official title of the awards, 2)

categories, and 3) naming of the prizes. The new amendments will take effect starting from the 3rd edition of the WeGO Smart Sustainable City Awards in 2017.

Agenda 6: WeGO Corporate Partnership

The WeGO Secretariat proposed further discussions initiated back in 2013 on how to develop a long-term sustainable partnership model with the private sector for the future growth of WeGO but the Executive Committee did not provide any feedback.

The specific guidelines for the Corporate Partnership category will be further developed and presented by the WeGO Secretariat at the 4th WeGO General Assembly 2017 for final approval of the GA.

Agenda 7: Information on Election of the President City, Executive Committee Members, and Nomination of Vice President Cities

The Executive Committee took note of the information related to the upcoming election of the President City and Executive Committee members as well as nomination of Vice President Cities of WeGO at the 4th WeGO General Assembly 2017. Particularly, **Agra** (India) expressed its readiness to continue serving as an Executive Committee member, and **Hebron** (Palestine) – as a Vice President and Executive Committee member in the next term of 2017-2020.

Agenda 8: Information on Selection of the Host City of the Next General Assembly

The Executive Committee took note of the information related to the upcoming selection of the host city of the next General Assembly at the 4th WeGO General Assembly 2017. Particularly, **Agra** (India) indicated its interest in hosting the next General Assembly in 2020 as well as the so-called First Executive Committee Meeting in 2018, while **Hebron** (Palestine) expressed its interest in hosting the Second Executive Committee Meeting in 2019, rather than the General Assembly. **NITDA** (Nigeria) will reach out to potential host cities and local governments in Nigeria that would be interested in hosting any of the regular WeGO meetings.

Agenda 9: Use of Membership Fees

The Executive Committee **approved the WeGO Secretariat's proposal on the use of membership fees,** as proposed. Specifically, the WeGO Secretariat proposed usage of membership fees up to 109,000,000 KRW for various operational and program expenses. Particularly, membership fees will be used for projects related to the WeGO website update, creation of the WeGO Best Practices Journal and Online Sharing Platform, WeGO Secondment Staff Program, promotional activities, and other operational expenses.

Agenda 10: Tentative WeGO Work Plan for 2017

The WeGO Secretariat introduced the tentative plan of WeGO programs and activities for 2017 and the Executive Committee members as well as observers voiced several important suggestions throughout the Executive Committee session.

Annual Assessment

The Executive Committee will assess each Regional Office and its performance based on the following criteria:

The Annual Report will be presented and reviewed on these criteria:

- Annual Assessment: the Annual Report contains the Regional Office's operational progress for the past year as well as its business plan for the following year
- Review of the quality of the presentation of the Initial Term Report/Annual Report by the Regional Office at the Executive Committee meeting
- Regional WeGO activities initiated/conducted in the previous year(s)
- New WeGO members acquired in the previous year(s) in the respective region
- The overall fulfillment of the Role and Responsibilities of Article 4 and other provisions of the TOR by the Regional Office
- Financial stability and prospects of the Regional Office for the next year
- The Regional Office's relationship and cooperation with its regional members and with the WeGO Secretariat
- The Regional Office and host city's commitment to promoting e-Government and ICT in the city, country and region of its location.

Dissolution

Pursuant to Article 13.6.B of the WeGO Statute, a WeGO Regional Office may be dissolved pursuant to the results of the initial and annual assessment to be conducted under Article X of the TOR, or in the event that the Executive Committee decides that the conduct, omission, or negligence of the Regional Office causes harm to the mission or purpose and/or reputation of the organization.

According to Article 8.8 of the Terms of Reference for Regional Offices, each regional office shall "Submit an Initial Term Report/Annual Report to the WeGO Secretariat one (1) month prior to the annual Executive Committee Meeting. The Initial Term Report/Annual Report will contain a report on the Regional Office's operational progress for the past year(s) as well as its business plan for the following year. The Secretary

The next President City for 2017 ~ 2020 Term

After a call to all WeGO members earlier this year for candidates, Seoul is the sole candidate for the President City. Seoul has taken the lead in founding and managing the organization as its President and must continue to serve the role to maintain operational continuity of the Organization

Appointment of Next Vice President Cities for 2017 ~ 2020 Term

The WeGO statute stipulates the following: "The vice president cities shall consist of an executive vice president city and not less than five (5) vice president cities... The next host city of the General Assembly will automatically be appointed as the executive vice president city and vice president cities shall be appointed by the president city from among cities nominated by the Executive Committee."

A survey was circulated to all 14 Executive Committee Members earlier this year asking for nomination of Vice President cities for the 2017-2020 term. Among the cities that have been nominated by the Executive Committee, Seoul, if re-elected, is planning to appoint the following **seven (7)** Vice President Cities in alphabetical order:

Addis Ababa, Beyoğlu, Ha Noi, Jakarta, Mexico City, Moscow, Ulyanovsk Region

The WeGO Statute stipulates:

"The Organization shall have the Executive Committee comprising twenty (20) or less cities including the president city and vice president cities. The Executive Committee provides support for the projects and assists in the operation of the Organization. Any member city may join the Executive Committee **by notifying the Secretariat in writing of its candidacy one (1) month prior to the General Assembly.** Members of the Executive Committee shall be elected by the General Assembly taking into account equitable geographical distribution as much as possible."

As the state of digital technology evolves rapidly, the WeGO Secretariat, with approval of the 2016 Executive Committee, has taken the step to revise its Mission Statement and set out an ambitious 3-Year Strategic Plan. These were created in consultation with two expert consultants with feedback from our Advisory Panel. The General Assembly will vote to approve these changes, and the Secretariat believes that the changes, if approved, will move WeGO further in the direction that it needs to adapt in order to best serve the diverse and dynamic needs of its members. Here we present them for your consideration.

WeGO 3-Year Strategic Plan for 2017-2020

1. Introduction

The World e-Governments Organization of Cities and Local Governments (WeGO) was founded in 2010 by 50 founding member cities to promote sustainable city development by enhancing exchanges and cooperation on e-Government, to improve administrative efficiency and transparency by strengthening digital capabilities, to advance online public services for citizens, to increase civil involvement, to bridge the digital divide, and to create a common ground for direct cooperation and solidarity among cities.

WeGO has now grown to 120 members with numerous annual programs and activities for members like the: Seoul e-Government Training Programs 1 & 2—Joint Workshop for e-Government and Smart City—Asia-Pacific Regional Forum on Smart Sustainable Cities—Smart Cities Innovation Summit Asia—ICT Feasibility Study and Pilot Project; and E-Government and Smart City Tools like the: WeGO-TM Forum Smart City Maturity & Benchmark Model—eGovFrame—City e-Government Diagnostic and Solution (CeDS) —WeGO Citizen Participation System (CPS) solution.

With ever-increasing and passionate support of 120 WeGO members and excellent leadership of our President, Vice President cities, and Executive Committee members, WeGO will continue to move forward to better serve our Members as a platform for their transformative journey to become smarter and more sustainable cities.

2. Evolution of Purpose toward "Smart Sustainable Cities for All"

Digital technology for urban development is constantly moving forward. Technologies such as the Internet of Things (IoT), Cloud computing, Big Data and analytics, and Artificial Intelligence (AI) are spreading rapidly in cities around the world. The virtual cyberspace, traditionally confined to the world of software, is reaching into the real world through sensors and IoT. Cities are becoming more connected, possessing a wide network of things that are automated and constantly interacting with citizens, while at the same time gathering data sets that are run through Big Data Analytics and even Deep Learning by AI.

Meanwhile, cities around the world have faced an increasing array of sustainability challenges. Rapid urbanization, environmental degradation, and growing socio-economic disparities have all put pressure on the urban resources and city administration. Since the founding of WeGO in 2010, the UN Millennium Development Goals (MDGs) have been replaced by the 17 Sustainable Development Goals (SDGs) with 169 targets, spearheaded by the United Nations through a deliberative process involving its 193 Member States in 2015. Subsequently, 50,000 urban development stakeholders gathered at Habitat III in Quito, Ecuador, to declare the "New Urban Agenda", reinvigorating the global commitment to sustainable urbanization that leaves no one behind.

WeGO too needs to evolve to meet the new goals and challenges ahead, helping our members navigate fast-changing digital technologies employed in cities for smart sustainable urban development for all citizens. It is with this background that WeGO has been hard at work to redefine and update our mission in order to better serve our members in 2017 and moving forward into 2020 and beyond.

2.1. Challenges of urbanization and sustainability

The world faces an unprecedented urbanization rate. More than half of the world's people currently live in cities; and it is forecasted that 66% of the world's population will be living in urban areas by 2050, with the urban population surpassing 6 billion people. Cities are engines for innovation and economic growth, accounting for 80% of the global GDP. However, high density city population increases put strains on energy, transportation, water, waste management, housing, buildings and public spaces. Cities also consume around 75% of global energy and are responsible for 70% of the global greenhouse gas (GHG) emissions. Demand for services in urban areas is increasing rapidly; but against limited resources. We need to do more with less in order to build our sustainable future. So urbanization raises significant challenges in economic, social and environmental sustainability.

As the MDGs expired in 2015, the SDGs have been set for 2016-2030. In particular, among the 17 Goals, Goal 11 turns the spotlight on cities and specifically sets the goal to "Make cities and human settlements inclusive, safe, resilient and sustainable." Research findings have shown that 65% of all SDG targets, not just Goal 11, require local action for their successful implementation. Thus, effective local solutions are essential to meet global challenges.

In this regard, the transformative role of Information and Communication Technologies (ICT) in addressing urban challenges has been widely discussed and there is growing recognition that ICT has great potential to enable the SDGs and thereby support the sustainable cities of the future. A large number of cities around the world have adopted ICT to improve efficiency in the delivery of services and to encourage new collaboration and innovation that fuel socio-economic development. ICT has been used to enhance the quality and accessibility of city administrations as well as the healthcare, education and other systems, and to increase stakeholder involvement, including those at risk of being marginalized or excluded. Cities have also adopted ICT to reduce the environmental impact of development by optimizing urban mobility and making buildings and utility grids more energy-efficient.

2.2. Global Smart City Movement

The initiatives of 'Smart City' have emerged to address urban challenges around the world. Many cities have endorsed the Smart City concept and have endeavored to leverage the latest in technology and connectivity to address urban challenges, such as traffic congestion, safety and security, climate change

and other environmental issues, and aging urban infrastructure, in a 'smart' manner. In smart cities, digital technologies translate into better public services, better use of resources, liveability for citizens and workability for businesses. The New Urban Agenda, the outcome document of Habitat III, also endorsed the smart city approach that is expected to "provide options for inhabitants to make more environmentally friendly choices and boost sustainable economic growth and enable cities to improve their service delivery."

There are many different views on what a smart city is and thus there is no single, unified definition of smart city. A definition by the International Telecommunications Union (ITU) reads: "A smart sustainable city is an innovative city that uses information and communication technologies (ICTs) and other means to improve the quality of life, efficiency of urban operation and services, and competitiveness, while ensuring that it meets the needs of present and future generations with respect to economic, social, environmental as well as cultural aspects. The European Commission (EC) emphasizes the benefits of a city's inhabitants and businesses and defines a smart city as "a place where the traditional networks and services are made more efficient with the use of digital and telecommunication technologies, for the benefits of its inhabitants and businesses". On the other hand, Gartner, a leading IT research and advisory company, defines smart city as "an urbanized area where multiple public and private sectors cooperate to achieve sustainable outcomes through the analysis of contextual real time information shared among sector-specific information and operational technology systems."

It is important to note that the smart city concept highlights the 'three dimensions of sustainability,' which consists of the economic, social and environmental sustainability. The term 'triple bottom line' is also often used to refer to the social (People), environmental (Planet) and economic (Profit) bottom line or sustainability. Solutions to the sustainability problem must ultimately make all three dimensions sustainable, because if any one dimension is weak then the system as a whole becomes unsustainable. Most national and local problem solving efforts tend to focus on only one dimension at a time, but the policy makers and practitioners will need to take a longer term perspective and thus evaluate the future consequences of decisions in terms of making all three dimensions sustainable. Thinking deeply in terms of the three dimensions of sustainability would require 'systems thinking,' as one starts seeing the world as a collection of interconnected systems.

In addition to the economic, social and environmental sustainability, the concepts and definitions of smart city in general highlight such characteristics as: the strategic use of new technologies; innovation; integrated ICT infrastructure; benefits for citizens and businesses; stakeholder engagement and citizen focus; context-based and data-driven decision making; and multi-stakeholder partnerships, among others.

More recently, the concept of a smart city has been shifting from a top-down and mostly technology-driven approach, towards a bottom-up process that facilitates participation and collaboration among city stakeholders. In this latter respect, a smart city is seen as an ecosystem where open government data, smart applications, participation of citizens, collaboration among stakeholders, and Big Data Analytics based on real-time information drive innovation and competition. The city becomes a living laboratory where a large diversity of stakeholders such as user communities, research organizations, solution developers, local authorities as well as investors collaborate and co-create adoptable innovation solutions. A growing number of cities have set up urban 'living labs' based in real life communities and settings, which operate as intermediaries among citizens, research organizations, companies, and cities for joint value co-creation, prototyping and validation to scale up innovation and businesses.

For a city government to plan and execute a smart city strategy, it is necessary to have a means to assess its city wide capabilities and maturity across various aspects of a smart city. WeGO, in collaboration with its partner, TM Forum has introduced the WeGO-TM Forum Smart City Maturity & Benchmark Model which has been designed to assess a city's maturity across the key aspects of a city's transformation journey to become a smarter city. The Model allows a city to assess smart city maturity based on five dimensions: leadership and governance, stakeholder engagement and citizen focus, effective use of data, integrated ICT infrastructure, in addition to existing levels of smartness. The city can then set clear goals as to how it wishes to transform over the next two to five years, as well as benchmark itself against global best practices of other cities.

2.3. Objectives and Pillars of Smart Sustainable City

The goals for moving to a smart city differ between cities, and each city needs to set its own objectives based on citizen expectations as well as social, economic and environmental conditions of the city. It is also important to have measurements of the progress towards the city's smart city goals. Thus, smart city initiatives around the world start with a plan that clearly states the vision and key objectives, together with smart city governance roadmap and key performance indicators (KPIs).

The ITU, in collaboration with the United Nations Economic Commission for Europe (UNECE), developed a set of international KPIs for Smart Sustainable Cities which provide objective and comparative indices to measure the progress achieved in transitioning to a smart and more sustainable city. The WeGO Secretariat also participated in the consultation process of developing the ITU-UNECE KPIs. These KPIs can be useful in assessing how successful cities have been in accomplishing their smart sustainable city goals.

Cities and smart city experts have laid out a different set of pillars or dimensions of a Smart Sustainable City. The model described in Figure 2, developed by Boyd Cohen, has been widely used and is based on a holistic framework for considering what makes a smart city smart. The six pillars of Smart Sustainable City in this model include: Smart Government, Smart People, Smart Economy, Smart Living, Smart Mobility and Smart Environment. Table 1 provides more detailed information about the key components or features of each pillar.

Among the six pillars in Table 1, Smart Government reflects the evolution of government toward complete digital transformation. The advent of new digital technologies, together with citizen-centric approach, has led to a paradigm shift in the working of government around the world. The earlier initiatives of e-Government focused on the use of IT system, such as computerization and online services, for process innovation with the goal of improving administrative efficiency. The focus has subsequently been shifted to open government or platform government that are open to people, using web and mobile applications. WeGO's new service, Civic Participation System (CPS) solution, reflects our efforts to help Members in this regard. Moving beyond, Smart Government utilizes intelligent digital networks based on sensor, IoT, cloud-based services, more powerful mobile devices, Big Data and analytics, etc. to analyze and understand the functioning of the city and generate sustainable public value. It would integrate information, communication and operational technologies across multiple domains and jurisdictions, and use integrated real-time data to make decisions in allocating public resources.

ICT has thus the potential to make a significant impact on urban sustainability. However, it is important to note that availability does not necessarily mean accessibility. ICT products and services may be available in a city, but may not be practically accessible to all segments of the population due to a lack of affordability or education. This may exacerbate the digital divide by increasing the influence of the haves while reducing the influence of the have-nots, thus further worsening urban inequality. Thus, concerted government efforts are required to achieve Smart Sustainable Cities for all citizens that leave no one behind in this rapidly digitizing world

3.3. Strategic Goals & Activities for 2017-2020

With our updated mission laid out before us, and our renewed values guiding us, WeGO will transform to more effectively serve our Members in pursuing smart sustainable urban development. We will offer new programs and expand on existing activities and programs to encompass the increased scope of our mission. WeGO's ultimate goal will be to help our Members realize their Smart Sustainable City goals with tangible initiatives and projects that benefit the welfare of all citizens and sustainability of cities.

This section presents WeGO's strategic goals for the period from 2017 to 2020 and the new activities to be undertaken to achieve these goals. It should be noted that the activities below refer the new activities and programs that will be offered, in addition to the on-going WeGO programs such as annual Feasibility Study, Digital Capacity Building Programs, ICT Tools, and ICT conferences, workshops, and international events.

Goal 1: Strengthen Capacity Building

As an organization with the mission to promote and facilitate the transformation of cities to Smart Sustainable Cities, strengthening the capacity of our Members will always be the priority of WeGO in order to help city leaders, practitioners and stakeholders develop and implement transformative solutions for Smart Sustainable Cities.

For the period 2017-2020, WeGO will:

- Build and strengthen WeGO Digital Capacity Building Programs by expanding existing training
 programs to comprehensive programs on smart sustainable urban development. In particular, the
 Programs will reflect the diversity of Members in terms of city vision and goals, socio-economic
 conditions, existing levels of ICT infrastructure and connectivity, governance and other capabilities,
 among others, in order to better able each Member to plan and execute Smart Sustainable City
 initiatives and meet the local needs of their cities. Specific focus will be given to systems thinking,
 open innovation and design thinking approaches as well as integrated foresight, decision-making,
 and management processes that can lead to actual project implementation.
- WeGO Online Smart Classroom: Provide standardized and ad-hoc online training services to Members. The content will include global trends and local best practices on Smart Sustainable Cities as well as understanding of advanced technologies. These online training programs will include:



- → Programs for basic ICT topics as well as the latest topical issues such as IoT, AI, Cyber Security, and 4th Industrial Revolution
- → A series of interactive web-based seminars, featuring specific Smart Sustainable City issues. The WeGO Secretariat and Regional Offices will organize and host the webinars, but Members and external experts will also be invited to offer lectures.
- → Composite form of online-classroom lectures and homework assignments; an official WeGO certification will be accredited according to the achievement at the completion of the courses
- Assist interested Members to implement the WeGO-TM Forum Smart City Maturity & Benchmark Model which allows cities to assess their development as a Smart City and benchmark other leading cases. The participating cities will receive a comprehensive post-assessment consultation and a full benchmarking report.
- Assist Members to implement the KIs for Smart Sustainable Cities by collaborating with ITU. This will
 allow cities and their stakeholders to assess the degree of success in achieving the objectives of
 smart sustainable city projects.
- Assist Members to adopt WeGO Civic Participation Systems (CPS) solution that allows cities to efficiently and comprehensively collect and manage the concerns of their citizens. Members wishing to use this digital-capacity-enhancing system themselves will receive both the proprietary program and a training manual on how to properly enact the system in their city.

Goal 2: Platform for action-oriented cooperation

WeGO will build and develop an effective platforms to facilitate city-to-city exchange, benchmarking, learning, knowledge transfer and collaboration for collective problem-solving among Members. The new platforms will support Members to co-create innovative Smart City solutions for their particular challenges, followed by actual implement of the initiatives.

For the period 2017-2020, WeGO will:

- Set up and facilitate action-oriented thematic clusters with a grouping of WeGO Members around a core area of interest in pursuing their smart city vision and objectives. The themas for the thematic clusters will include:
 - → Smart Government;
 - → Living Labs for Open Innovation;
 - → Big Data and Data-Driven Policy;
 - → Smart Mobility;
 - → Smart and Low-Carbon City;
 - → Additional themes based on WeGO Members' needs

The WeGO Secretariat will facilitate the thematic cluster members to share challenges, experiences, innovative solutions and success stories, as well as forge new partnerships on Smart City projects that can lead to actual project implementation. WeGO will bring in more stakeholders from the private sector, academia, and other experts into the group conversation and activities in order to facilitate multi-stakeholder horizontal partnerships and financing for the cluster groups to successfully implement Smart City projects around the world.

- Set up online communication and exchange platform for Members. In addition to the usual communication channel through the WeGO Secretariat, direct online communication platform will be established to facilitate dynamic exchange of ideas, policies and practices among Members.
- Assist Members in their efforts to move beyond pilot projects and demonstrations to actual Sustainable Smart City projects implementation. In particular, as the capacities of cities to implement bold and innovative solutions are often significantly constrained by financing obstacles, the WeGO Secretariat will assist Members by working on models and methods to finance local initiatives, including Public-Private Partnership (PPP) models, and potential sources of financing.

Goal 3: Knowledge Building and Research

WeGO's activities to support the transformation of Members to Smart Sustainable Cities need to be based on extensive and up-to-date knowledge base. This will require the efforts of the Secretariat as well as Members for knowledge building through collection, analysis and synthesis of Smart City cases and data as well as more in-depth research in the Smart Sustainable City field. It will also require systematic knowledge management to keep up-to-date knowledge base, and to subsequently allow Members to actively access and use the accumulated information.

For the period 2017-2020, WeGO will:

- Establish Smart Sustainable City knowledge database which contains digital policy agenda, global trends, emerging technology trends, and best practices.
- Build a comprehensive WeGO Smart Sustainable City Projects Catalog where Members can access
 project cases from around the world and network with the cities and companies who have
 successfully planned and implemented the initiatives. The Catalog will include details on project
 background, main features, technical details, challenges, statistics, impact, budget and financing so
 that members can learn from and perhaps implement in their own city.
- Conduct research and publish an online WeGO Smart Sustainable Cities Best Practices Journal, highlighting some of the best entries in the Catalog with more detailed analysis on key challenges and lessons for Members to see.

Goal 4: Diversified Membership and Partnerships

Smart Sustainable Cities initiatives often require inclusive multi-sector partnerships encompassing the public, private and civil society sectors. In line with WeGO's new mission, we will endeavor to enlarge the scope of WeGO membership and partnerships to better enable multi-stakeholder partnerships. At the same time, we will endeavor to provide better and more customized service to Members by increasing Secretariat capabilities, expertise and knowledge.

For the period 2017-2020, WeGO will:

- Attract Corporate Members for long-term and sustainable partnerships. The Secretariat will endeavor to bring Corporate Members' perspectives and expertise into the working of WeGO and also help WeGO city Members to pursue real projects with Corporate Members to better enable the implementation of Smart Sustainable City initiatives.
- Strengthen partnerships with international, regional, and national organizations as well as sub-national local government associations, including the ITU, UN, World Bank, Asian Development Bank (ADB), African Development Bank (AfDB), ICLEI, UCLG, and FMDV. Also, we will help connect Members' projects to public financing institutions like the World Bank, ADB and AfDB, as well as private financing institutions.
- Attract city Members from underrepresented regions and nations for a more diversified and global city membership. We will also forge more active partnerships with the academia and experts in order to enrich our knowledge base and strengthen research and analytical capabilities.
- Strengthen Secretariat capabilities and empower Regional Offices. In order to better serve Members, we will strengthen Secretariat capabilities and expertise. We will also endeavor to empower Regional Offices through capacity building, joint projects, staff exchange and traineeship programs, among others. Where appropriate, we will establish Member-hosted satellite centers on a specific theme or project with the aim to enlarge our capability and expand national or regional outreach.

4. Conclusion

The WeGO 3-Year Strategic Plan for 2017-2020 is the first attempt to spell out the medium-term plan since the organization's establishment in 2010. The objective of the Plan is to better serve our Members in their transformative journey to become smarter and more sustainable cities. It will be positioned as the primary reference for WeGO's operation and will be complemented by WeGO's Annual Plans which will include detailed targets and performance indicators. Annual performance monitoring and evaluation will ensure that the Plan and goals are on track.

Updating WeGO's name

Much of the world has moved past simple "e-Government" into "Smart Government" inside the framework of Smart Sustainable Cities. WeGO must also evolve from a name that only reflects part of its evolving mission, from e-Government to Smart Sustainable Cities.

The acronym name "WeGO" will remain the same to acknowledge the history and brand of the organization, but the organization's name must be updated to "World Smart Sustainable Cities Organization," as we look to the future beyond just e-Government. Please note that "Smart" encompasses "Smart Government," which is larger in scope than just "e-Government". E-Government will continue to be part of WeGO's mission inside Smart Government, which is part of Smart Sustainable City.

"Cities" includes not just traditional cities but all local governments, states and regions at a subnational level as defined in our statute.

REVIEW OF PROPOSED CORPORATE MEMBERSHIP CATEGORY

Corporate Membership Category Approval

New membership and funding strategy discussions were held as early as Executive Committee Meeting 2011, continuing in Executive Committee Meetings 2013, 2015, and in 2016. Since the founding, WeGO has been dependent on membership fees paid by full members and also contributions by the President City. Over the many years of discussions by Executive Committee members on this subject there have been two major agreements:

- 1. WeGO must develop long-term and sustainable partnerships with global companies in order for the organization to grow
- 2. These corporate entities should not have the same status as city members, who are the primary founders of WeGO

Previous EXCOM approval that hold relevance:

Executive Committee Meeting 2011: Approved on attracting sponsorship from private companies for WeGO meetings and events, resulting in sponsorships of WeGO General Assemblies held in Barcelona (2012), Chengdu (2014), and Ulyanovsk (2017)

General Assembly 2014: Approved the new membership category of: "Friendship Member," defined as "any regional association of local governments; or any government agency or governmental entity that is directly concerned with local e-Government issues; whose membership was approved by the Executive Committee."

Discussion and Approval of new WeGO membership category of "Corporate Member":

- Corporate Members will have the same rights as Associate Members, namely: may attend regular sessions of the General Assembly and present their opinions on matters of, including but not limited to, the Statute, projects and annual membership fees, but not vote, approve, decide on matters, or hold executive positions (suggested changes in Agenda 4)
- All prospective corporate members must be approved by the Executive Committee and pay annual membership fees based on the number of employees (membership fee chart in Agenda 4, Annex 3). Small to Medium Enterprises (SMEs) will pay less than large Multinational Corporations
- Corporate Members will contribute to discussions by adding private-sector perspectives on urban development issues and help WeGO Members form Public-Private Partnerships for Smart Sustainable City projects

Summaries of discussions from 2014 and 2015 EXCOM

At the **2014 Executive Committee** meeting, under Agenda 4: "New Membership and Funding Strategies" it was first proposed that corporate members be adopted along with friendship members. However, after some discussion, the topic was tabled until the 2015 EXCOM.

Consequently, "Corporate Membership" was included as Agenda 8 at the 2015 Executive Committee. Feedback on the idea was largely positive, with Seoul and Ulaanbaatar in particular voicing support. However, as the new membership category requires General Assembly approval, it was again tabled for further discussion at the 2016 Executive Committee.

Memorandum of Corporate Member Category discussion from 2016 Executive Committee meeting.

The 2016 EXCOM Agenda 6 Memorandum on "WeGO Corporate Partnership" is presented here as it is the most recent and relevant discussion of the proposal:

The WeGO Secretariat proposed further discussions, initiated back in the 2013 EXCOM, on how to develop a long-term sustainable partnership model with the private sector for the future growth of WeGO but the Executive Committee did not provide any feedback. Observer NITDA (Nigeria) mentioned that the WeGO Secretariat should take into account local dynamics in different countries, for example, Nigeria where smaller entities, rather than large corporations, are more likely to be involved in such activities.

At the last Executive Committee Meeting in 2015, the corporate membership category was discussed with favorable feedback conditional upon clear quidelines of corporate partners' benefits and responsibilities. Henceforth, the specific guidelines for the Corporate Partnership category will be further developed and presented by the WeGO Secretariat at the 4th WeGO General Assembly 2017 for final approval at the General Assembly.

REVIEW OF AMENDMENTS TO THE WEGO STATUTE

The Secretariat will propose a number of amendments to our statutes, which will be voted upon at the General Assembly for approval. The Secretariat believes that these changes more accurately reflect the needs of the organization. Here we present them for your consideration.

Statute Amendments

Executive Summary of Suggested Amendments to WeGO Statute:

Article 1,3,4: Terms have been adjusted to match the updated WeGO Mission, Vision, and Name Change (Agenda 2 of this document), from "e-Government" to "Smart Sustainable Cities".

Article 5, 6, 8, 14: New membership category: "*Corporate Member*," has been added. Corporate members may attend regular sessions of the General Assembly and present their opinions on matters, but not vote, approve, decide on matters, or hold executive positions (Agenda 3 of this document).

Article 10: Gives the General Assembly the authority to make the final selection of next host city, instead of just confirming decisions made by the Executive Committee. Additionally, grants the Organization more flexibility to approve hosts to alleviate difficulty in locating the next General Assembly and Executive Committee meeting hosts.

Article 11: Gives the Organization flexibility to add the Executive Vice President as a special 21st member to a full complement of 20 Executive Committee members.

Article 12: Mandatory discussion provisions for Executive Committee meetings have been replaced with flexible discussion options and gives Executive Committee the power to decide on the host of the General Assembly in the years the General Assembly is not held, to give the Organization more time in locating an appropriate host.

Article 13: Gives more opportunities to WeGO members to host new Regional Offices and gives the Executive Committee more flexibility to dissolve existing Regional Offices.

Article 15:

- 1. Reflects "Smart Sustainable City Awards" name change approved by Executive Committee Meeting 2016.
- 2. Title of Regional Office head changed to "Regional Director" to avoid confusion with the title of WeGO "Secretary General".

Article 16: The ratio to form a "quorum" has been decreased. This will allow for more flexibility in organizing meetings as membership numbers increase.

The City of Sejong is a newly planned city as one of the biggest national agendas in the Republic of Korea. Officially named Sejong Special Self-governing City, it is the nation's de facto administrative capital. In early 2007, the central government vowed to build a special administrative district, situated 120 kilometers away from the metropolitan city of Seoul. The goal was to reduce the influence and dominance of Seoul on national governance and economics, whilst promoting the regional development of other areas of the country. The new city opened on July 1st, 2012

The city is being constructed into three phases according to a budget of approximately USD \$20.6 billion. To date, about USD \$12 billion, or 60% has been invested in the city's construction. The following table shows the Sejong City Project's a brief masterplan into three phases;

In the meantime, to keep up the pace with the 21st century, the urban development has been focusing on the convergence of eco-friendly technology and top-notch information communication technology from the very beginning stage of the dity's construction. For instance, an extensive green space has been created in the center of town while residential and office buildings are

located around it—resembling a ring. This was done as a way to address the typical urban problems of pollution, housing shortages, and traffic congestion, etc., from the outset. For this clean and green environment, 411 km long underground conduits (to be stretched to 1,000km by 2030) for the supply of power, water and telecommunications are also controlled at the Sejong Smart City Center. Likewise, the city's automatic waste-to-fuel recycling system with the daily capacity of 30 tons is monitored by an IT solution.

The Sejong Smart City Center is the control tower for a wide range of smart services including real-time traffic information, operation and monitoring of security cameras with two-way communication channels, fire/disaster prevention network connected to local fire stations and police stations, and other smart services that are easily available with smartphone applications. Of the total budget, approximately USD \$140 million will be sent to smart city services by 2030.

The Sejong City government, led by Mayor Dr. LEE, Choon-hee, is going to celebrate its 10th anniversary for the start-up and 5th anniversary for the inauguration in the coming July 2017. Merely 5 years later, Sejong is now outperforming in many aspects with the rapid growth in population of 250,000 today (versus 105,000 in 2012) contributing to the balanced development as well as harmonious growth nationwide. In addition, Sejong ranked top in 2016 amongst 17 provincial governments in the nation in terms of its excellence in local governance and initiatives for green environment.

Particularly in terms of the digital governance initiatives, Sejong has also made several achievements. The Sejong Smart City system acquired the ISO (International Organization for Standardization) 22301 certification for business continuity management to protect against, reduce the likelihood of, and ensure the business recovers from disruptive incidents for the first time in Korea in 2016. Also, a smartphone-based digital government system was firstly introduced early this year to foster communication with ditizens.

Now, Sejong is seeking a momentum to flourish for the next 100 years, looking back the past 10 years. The city has a vision a world class livable place with the use of eco-friendly ICT technology, bridging the digital divide between the rural and urban areas, providing administrative efficiency and openness, and economically and environmentally sustainable for future generations.

This is the reason why the City of Sejong is submitting a bid package for the 5th WeGO General Assembly 2020. Hosting the General Assembly will be a great chance to interact with other member organizations as Sejong wishes to achieve this vision by collaborating with other international cities and stakeholders worldwide. Likewise, Sejong will be the first to share good practices and knowledge.
