Eligibility

All private sector businesses, including small to medium enterprises to large multinational corporations

Application Procedure

1. Please complete and submit the Membership Application Form signed by the Chief Executive Officer, President, or authorized representative of the company to the WeGO Secretariat.
2. After the submission of the application, a Corporate Member will be confirmed upon the approval of the Executive Committee of WeGO.

Member Rights

1. The authorized representatives of Corporate Members can participate in all WeGO programs.
2. The authorized representatives of Corporate Members can attend the General Assembly and present their opinions.

Member Responsibilities

1. Corporate Members should participate in projects and meetings of WeGO actively.
2. Corporate Members should endeavor to share good practices and knowledge on smart sustainable solutions with other cities and local governments worldwide.
3. Corporate Members of WeGO should pay the annual membership fee following the chart below.
4. Corporate Members should maintain updated contact information with the WeGO Secretariat at all times.
5. Corporate Members should promote WeGO to other companies, cities, and partner organizations for the expansion of the WeGO network.

Membership Fees

Members should begin to pay annual membership fees starting from the year following the year when they become an **official Corporate Member** of WeGO. Membership fees vary depending on the number of employees worldwide.
