## The 6<sup>th</sup> WeGO General Assembly Highlights



Under this year's theme "Smart City, Smart Citizen", the 6th WeGO General Assembly successfully convened in Seoul from 25th to 27th September 2023. This year, the General Assembly was the first of its version to have such a grand gathering in person from around the world after the COVID-19 pandemic. It was a meaningful reunion among WeGO Members and partners as we also celebrated the inaugural Seoul Smart City Prize Ceremony. The 6th WeGO General Assembly gathered more than 200 offline participants.

The 6th WeGO General Assembly welcomed 58 city representatives from over 30 countries. There were twenty four (24) mayoral-level representatives (Governor, Mayor, and Vice Mayor or Deputy Mayor) in total attending the Session both in person and online, representing a total population of 130,996,081 citizens from five (5) different regions, including Central Asia, East Asia, Middle East, Oceania, South Asia, and Southeast Asia.

During the General Assembly session, Seoul was approved as the President City of WeGO together with Kampala and São Paulo as the Vice President Cities of WeGO for the term from 2023 to 2026.

Seoul has been the President City of WeGO since the establishment of WeGO in 2010. With a population of nearly 10 million people in the metropolitan area, Seoul has evolved into a leading smart city as a prime example of inclusive and trend-setting policies for improving urban life for its citizens. Seoul aims to be a smart city that improves the quality of citizens' lives by connecting multiple entities across the city using digital infrastructures as a basis and through the convergence of the ICT technologies. Seoul also provides capacity building for all citizens to encourage each individual to become an active participant in the development of a sustainable smart city that is inclusive with no one left behind. Together with WeGO members, Seoul will continue to serve the WeGO's mission and contribute to bringing smart sustainable development for all citizens globally.

One of the new Vice President Cities, Kampala has been a WeGO Member since 2017. As the capital city of Uganda, Kampala is set to become the country's first smart city. Kampala was also selected as the lead city among twelves (12) African cities in the Africa Smart Towns Network (ASToN). Providing the pivotal role of Kampala in Africa, Kampala's position as a Vice President City is a good representation of WeGO members from the African region in the organization. On the other hand, one of the new Vice President Cities, São Paulo is one of the founding members of WeGO since 2010, and is not only a financial center of Brazil but is also the largest city of Brazil. São Paulo was ranked first in Brazil's "Connect Smart Cities 2021" and is one of the crucial leading smart cities in Latin America. The new Vice President Cities of WeGO will lead the and will promote WeGO's values in the global smart cities community.

At the 6th WeGO General Assembly, to the existing three (3) regional offices that includes African Regional Office in Abuja (Nigeria), East Asia Regional Office in Chengdu (China) and Mediterranean Regional Office in Beyoğlu (Turkey) another three (3) WeGO Regional Offices were established. WeGO welcomed the opening of the Middle East Regional Office in Abu Dhabi (United Arab Emirates), Central Asia Regional Office in Almaty (Kazakhstan), and Latin America Regional Office in Cuenca (Ecuador). With the establishment of these new regional offices, region focused smart city activities and programs will further flourish in the respective regions.

During the General Assembly expressions of interest in joining the WeGO family were received from seven (7) new entities including six (6) local governments from Kaohsiung, Lusaka, Madinah, Madrid, Nansana, and Turkestan Region, and one (1) corporate from Dassault Systèmes.

In addition to the main session, delegates joined in on a special tour program beautifully demonstrating the culture and innovative characteristics of Seoul. Delegates marveled at the beauty of Seoul via leisurely city tour bus ride through the heart of North Seoul; critically engaged with brilliant minds behind Seoul's success in smart tourism and smart city development through technical sessions provided by Urban Design Institute of Korea and Seoul Tourism Organisation. For nourishments, delegates enjoyed traditional dishes containing the harmony with nature at "Sanchon" a vegan cuisine inspired by Buddhist practice of "do no harm" and fun street food adventures at the Gwangjang Market.

Finally, during the General Assembly, the first Seoul Smart City Prize Ceremony was held in the Dongdaemun Design Plaza. It's a major urban development landmark designed by Zaha Hadid and Samoo. The Seoul Smart City Prize has been designed to promote an innovative yet inclusive smart city model that looks after underprivileged groups in the era of the Fourth Industrial Revolution that is driven by information and communication technology. This core mission serves as the basis of the two categories of the Prize, Tech-InnovaCity and Human-CentriCity, as WeGO and the Seoul Metropolitan Government envision that smart city should be defined and measured in terms of being both human-centric and technology-centric, rather than merely being centered around the advancement of technology.


"In 2015, the world's leaders committed to the seventeen UN Sustainable Development Goals (SDGs). They also signed the Paris Agreement, a legally binding international treaty on climate change aiming to limit global warming to 1,5°C and to significantly reduce greenhouse gas emissions by 2030. Achieving these very ambitious goals will require global cooperation at the policy level. And it will also require innovation and collaboration among the public and private sectors as well as civil society.

And, finally, it will require both a systems approach and behavioral change. Instead, the COVID-19 pandemic, the global consequences of the war in Ukraine and the extreme weather events that have wreaked havoc have pushed us off-track in achieving the SDGs.

Technology has been at the heart of progress toward the SDGs. 5G networks and meaningful deployment of artificial intelligence (AI) and Internet of Things (IoT) can do wonders in ensuring that we don't leave our vulnerable populations – our children, our elderly and those with disabilities – behind. However, today, even in the smartest of the smart cities, the focus is mostly on climate and energy transition, transportation, business, and entrepreneurship. Much less attention has been paid to its citizens' wellbeing. In the absence of meaningful engagement and programming, children and youth spend their days online falling victim to exploitation, abuse and radicalization. The elderly increasingly depend on accessing online services for health, banking and the like without sufficient knowledge of how to use their digital devices. And the impoverished remain unconnected and deprived of basic public services" - said Chairperson of the Board, Sweden for UNHCR, Dr. Joanna Rubinstein.

**Hong-seok Koo**, Ambassador of international relations of the Seoul Metropolitan Government moderated the 6th WeGO General Assembly.

The 6th WeGO General Assembly Session that took place on September 26th 2023 in the Seoul City Hall, Damokjeok Hall attracted more than 200 members, partners and observers including 19 mayoral-level representatives, who participated in the General Assembly Session both in person and online. In addition to the WeGO local government members, there were five (5) WeGO corporate members who joined in the session together. Mr. Hong-seok Koo, the Ambassador of International Relations for the Seoul Metropolitan Government, assumed the role of Chairman, complemented by the adept moderation of Ms. Jung Sook Park, the Secretary General of WeGO. The session unfolded with a comprehensive review and approval of eight

agendas crucial to shaping the direction of WeGO's activities and programs for the coming three years.

In accordance with the Article 16 (2) of the WeGO Statute stipulates that "General Assembly and the Executive Committee shall be considered adopted with the attendance of one fourth or more of the total members of the Organization" the attendance of one-fourth or more of the organization's total members for the adoption of General Assembly and Executive Committee decisions, a quorum of 41 members was deemed requisite. The 6th WeGO General Assembly was held with the presence of representatives of 45 WeGO Member Cities, collectively representing 130,996,081 population (please refer to Annex 1) from five (5) different regions.

During the General Assembly session, Seoul was approved as the President City of WeGO together with Kampala and São Paulo as the Vice President Cities of WeGO, and Almaty as the Executive Vice President City for the term from 2023 to 2026. Additional agendas, such as the deliberation and approval of WeGO EXCOM meeting outcomes for 2023, considerations for new memberships and withdrawals spanning the period 2021-2023, reporting on WeGO logo change, proposed amendments to WeGO Statutes, approval of the new EXCOM members, host city of WeGO EXCOM 2024, and the host city of 7th WeGO General Assembly have been reviewed and approved.

The territorial reach of WeGO broadened through the inauguration of three additional Regional Offices, thereby supplementing the existing three regional offices in Africa (Abuja), Chengdu (China), Beyoğlu (Turkey). Embracing the Middle East Regional Office in Abu Dhabi (United Arab Emirates), Central Asia Regional Office in Almaty (Kazakhstan), and Latin America Regional Office in Cuenca (Ecuador), the organization underscored its dedication to a worldwide presence and collaborative engagement.

### Agenda 1.

### Reporting of the WeGO Executive Committee Meeting (EXCOM) 2023

The WeGO Executive Committee (EXCOM) Meeting 2023 was hosted by Seoul, the President City of WeGO, online on September 4th, 2023 with 12 EXCOM Members (Abuja Municipal Area Council, Municipality of Beyoglu, Chengdu Municipal People's Government, Hebron Municipality, Kampala Capital City Authority, the City Government of Makati, The Government of Moscow, City of São Paulo, Seberang Perai City Council, Seoul Metropolitan Government, Ulaanbaatar City, Wellington City Council) attending the meeting. The EXCOM Members reviewed the annual report for the period from November 2022 to September 2023 presented by the WeGO Secretariat. The three following cities have been approved to become the new regional offices of WeGO for the term of 2023 - 2028: Almaty, Kazakhstan (WeGO Central Asia Regional Office), Abu Dhabi, United Arab Emirates (WeGO Middle East Regional Office), Cuenca, Ecuador (WeGO Latin America Regional Office). Additionally, Almaty, Kazakhstan was selected as the host city of the EXCOM Meeting 2024 and the host city of 7th WeGO General Assembly in 2026.

### Agenda 2.

### New Memberships and Withdrawals (2021~2023)

18 New Members joined to WeGO since the 5th WeGO General Assembly (7 new local governments, 9 new corporations and 2 new institutions have joined WeGO since the 5th WeGO General Assembly (Seoul, South Korea | October 2021)). Withdrawal of Members: one (1) local government and five (5) corporations (a total of six members) have formally withdrawn their status as members. Suspensions: twenty-two (22) local government members are suspended for the upcoming year due to long years of inactivity and no communication with the Secretariat. Termination of Members: twenty (20) corporate members have been officially terminated as members since the 5th WeGO General Assembly (Seoul, South Korea | October 2021)

### Agenda 3.

### Reporting on WeGO Logo change

The WeGO has proposed a review of the WeGO logo during the 2023 EXCOM meeting. The EXCOM members reviewed and agreed with the direction and the new logo initiative was approved by all members at the 6th WeGO General Assembly. The updated new logo name will be presented to EXCOM Members in 2024.

### Agenda 4.

### Report of the Proposed Amendments to WeGO Statutes

In accordance with Article 10 of the WeGO Statute, the Secretariat's efforts to update and refine the organization's statutes in order to reflect positive adaptation to progress, the EXCOM members have discussed the proposed amendments to the WeGO Statutes. For the mobilization of financial resources through profit-making businesses, and the new proposal for corporate/institution annual membership fee has been approved as the proposed amendments to WeGO statutes.

### Agenda 5.

### **Election of the New President City**

In accordance with Article 11 of the WeGO Statute, Election of the President City can be made at the 6th WeGO General Assembly. Seoul has been approved as the President city of WeGO for the term of 2023-2026. Seoul has taken the lead in founding and managing the organization as its President and must continue to serve the role to maintain operational continuity of the Organization.

### Agenda 6.

### **Appointment of Vice President Cities**

In accordance with the Article 11 (2) of the WeGO Statute stipulates that "The vice president cities shall consist of an executive vice president city and two (2) vice president cities." In consultation with EXCOM members, two (2) cities have been nominated as the next Vice President Cities, which was shared with the President City for final appointment. The following two (2) cities will be the new Vice President Cities for the term of 2023-2026: Kampala (Uganda), São Paulo (Brazil). All members approved the appointment of WeGO's Vice President Cities for the term of 2023-2026.

### Agenda 7.

### **Election of the New Executive Committee (EXCOM) members**

In accordance with Article 12 of the WeGO Statute, Election of new Executive Committee members can be made at the 6th WeGO General Assembly. A call was made on June 30, 2023. The fourteen (14) cities have been approved as the candidates as the new Executive Committee Members of WeGO for the term of 2023-2026, including Abu Dhabi / Department of Municipalities and Transport (The United Arab Emirates), Abuja Municipal Area Council (Federal Republic of Nigeria), Almaty City Administration (Republic of Kazakhstan), Chengdu Municipal People's Government (People's Republic of China), Autonomous and Decentralized Municipal Government of the Cuenca Canton (the Republic of Ecuador), Hebron Municipality (the State of Palestine), the City Government of Makati (The Republic of the Philippines), Kampala Capital City Authority (the Republic of Uganda), Maputo Municipality (Republic of Mozambique), Ramgram Municipality (Federal Democratic Republic of Nepal), City of São Paulo (the Federative Republic of Brazil), Seberang Perai City Council (Malaysia), Seoul Metropolitan Government (the Republic of Korea), Wellington City Council (New Zealand).

### Agenda 8.

### Selection of the Host City of 7th WeGO General Assembly

In accordance with Article 10 of the WeGO Statute, Selection of the host city of the next General Assembly was made at the 6th WeGO General Assembly. Almaty, Kazakhstan has been approved to be the next host city of 7th WeGO General Assembly in 2026. In accordance with the Article 11 (4) of the WeGO Statute stipulates that "The next host city of the General Assembly will automatically be appointed as the executive vice president city". In conjunction with this, Almaty will automatically be the Executive Vice President city for the term of 2023-2026.

# The 7<sup>th</sup> WeGO General Assembly 2026 (Almaty City, Kazakhstan)



This year, WeGO opened the bidding process to host the 2024 EXCOM Meeting, and the 7th WeGO General Assembly (GA) in 2026. The Secretariat has received a bidding proposal from one member, Almaty, Kazakhstan to host both the events. Almaty's bid to host the 7th GA in 2026 has been reviewed by the EXCOM Members and approved during the 6th WeGO General Assembly by WeGO Members. As a member of the WeGO organization since 2020, Almaty has recognized the advantages and opportunities provided by the organization for city development. The city has applied for the Seoul Smart City Prize with several projects, including the "Almaty Data Lake" and the "Geoanalytics Platform." Almaty also aspires to open a Regional Office (Central Asia) of WeGO.

Almaty's primary asset is its high-quality human capital, with knowledgeable and skilled citizens actively realizing their entrepreneurial potential. Small and medium-sized businesses contribute 47.5% to the city's GDP and employ 65.4% of the city's workforce. The city's public and business environment fosters growth in information development and the knowledge economy. Almaty stands as a city of youth, with an average age of 33.6 years, hosting a third of the country's universities and accommodating 255,000 students. It also houses over 3,000 IT companies and 15,000 developers. Almaty serves as a significant scientific hub, with 31% of the country's scientific organizations and nearly 39% of the research and development budget operating within its boundaries.

To enhance the quality of life for its citizens and ensure sustainable urban development, Almaty has prioritized the integration of innovative technologies and the establishment of effective governance mechanisms. In line with this vision, the "Program for the development of the city of Almaty until 2025 and medium-term prospects until 2030" was developed through collaboration with non-governmental organizations, city activists, business representatives, and international consultants. The program, approved by the state bodies of Kazakhstan in 2022, encompasses over 400 projects across key areas: Polycentric development, Sustainable economic growth, Development of transport and transport infrastructure, Improving the quality of communal services, "Green Almaty", "Safe City", Support for youth development, culture, and sports, Inclusive environment, education, and medicine.

The program adheres to several guiding principles, including an integrated approach to development based on the principles of ESG (Environmental, Social, Governance) and the UN Sustainable Development Goals. It emphasizes the interconnection between various aspects of society and the city's economy, such as education, healthcare, culture, a healthy lifestyle, economy, IT, and creative industries. The program also prioritizes inclusiveness in the urban environment, the reasonable use of natural resources, and the involvement of the population and business in city management processes through program document discussions. The program's implementation is coordinated by the "Almaty City Development Center" JSC, with specific activities and aspects overseen by the Akimat administration. Almaty's commitment to becoming a smart city by 2030 is evident. The city has moved up one spot in the United Nations (UN) Global E-Government Development Index (EGDI) for electronic government development, ranking 28th in September 2022.

Almaty has also gained recognition as one of the most advanced cities in Asia, according to a Bloomberg report based on ThoughtLab's research program "Building a Future-Ready City." The city's Almaty City Data Lake project was a finalist in the IEEE (The Institute of Electrical and Electronics Engineers) as the best Data Governance solution at the city level in 2022. Almaty is currently implementing various projects under the "Smart City" subprogram, including the Situation Centre of Akimat (city hall), Almaty City Data Lake, a unified video monitoring system, and contact centers for public utilities and emergency services. Future plans include the development of an automated traffic control system, a social e-card for citizens, a telemedicine center, the automation of utility accounting systems, and the creation of a "Digital Twin" of Almaty.

In conclusion, Almaty is experiencing steady growth and has achieved significant milestones in economic development, informatization, and human capital. The country's strategic location and stable political system contribute to its appeal as an investment destination. Almaty, with its vibrant business ecosystem and focus on smart and sustainable urban development, stands as a regional hub in Central Asia. The city's programs and projects aim to enhance the quality of life for its citizens and ensure inclusive and responsible development. As a member of WeGO, Almaty actively pursues collaborations and recognition for its innovative initiatives, solidifying its position as an emerging smart city in the region.

Along with the 6th WeGO General Assembly session, a side session was hosted focused on the topic of useful tools for evaluation and sustainable management to achieve smart city goals. The main speakers for this session was Bruno Lanvin, President, IMD Smart City Observatory, Sukwon Lee, Professor, Seoul National University Graduate School of Public Administration. Moderator Professor Jae Moon, Underwood Distinguished Professor, Yonsei University, Department of Public Policy and Management. This topic was aligned with WeGO's work on smart city index as WeGO has partnered with the IMD Smart City observatory to publish the Smart City Index 2023. The Index produced by The Smart City Observatory in partnership with WeGO differs from others by being citizen-centric. The IMD Smart City Index is distinctive because it utilizes city-level data from the Human Development Index. This comprehensive approach considers various indicators, such as life expectancy, education, and income, offering a more holistic view of the quality of life for city residents, as opposed to country-level data.

## **Seoul Smart City Prize**



Established in 2023, the Seoul Smart City Prize triennial competition that recognizes and promotes local governments with exemplary projects and solutions that use ICT to improve the quality of life of citizens.

The Seoul Smart City Prize was held in MarchJuly 2023. Local governments, corporates, institutions competed with their projects in the following categories: TechInnovaCity, HumanCentriCity and Leadership. Out of the 200 applications from 47 countries and 93 cities from regions of Asia, Africa, Europe, Latin America, the Middle East, North America, and Oceania. Worldwide projects were conducted across cities, institutions, and corporations and also received several individual nominations.

For the evaluation, the Seoul Smart City Prize partnered with a renowned institution, the Center for International Development Evaluation (CIDE) at Seoul National University for its methodology. The research team committed to substantial research in developing the evaluation criteria and indicators for the prize. The research includes the theory of change for the assessment of policy design and implementation.

The evaluation methodology incorporates data collection and analysis processes to input the indicators or variables that measure each city's circumstances or potential for development into a theory based statistical formula. Within the methodology, the efforts put into building inclusive and citizen centric smart cities were considered a fundamental factor.

The main body of operation for providing insight and direction of the Seoul Smart City Prize is the Organizing Committee. These representatives also pertain to the smart city sector giving professional consultation and recommending suitable candidates for the Evaluation Committee. The Organizing Committee also serves to encourage the promotion of the prize and its global visibility.



She worked at The Ohio State University for 16 years, serving as the vice provost for capital planning and regional campuses, associate dean of the College of Engineering, head of city and regional planning, and a professor during her time there. 

The meeting started at 15:00 KST and ended on time at 16:35. All agendas have been approved on the 26th of September 2023 during the 6th WeGO General Assembly 2023.

### Agenda 1.

### Reporting of the WeGO Executive Committee Meeting (EXCOM) 2023

The WeGO Executive Committee (EXCOM) Meeting 2023 was hosted by Seoul, the President City of WeGO, online on September 4th, 2023 with 12 EXCOM Members (Abuja Municipal Area Council, Municipality of Beyoğlu, Chengdu Municipal People's Government, Hebron Municipality, Kampala Capital City Authority, the City Government of Makati, the Government of Moscow, City of São Paulo, Seberang Perai City Council, Seoul Metropolitan Government, Ulaanbaatar City Government, Wellington City Council) attending the meeting.

The EXCOM Members reviewed the annual report for the period from November 2022 to September 2023 presented by the WeGO Secretariat.

# Annex 3. Proposed Amendments to WeGO Statutes: Membership Fee Updates

To simplify the distinction between the different types and categories of institutional and corporate members and to facilitate their membership payment through a more universal quote, the annual membership fee for institutional and corporate members will be updated accordingly.

The new proposed amendment is to remove the distinction between different types and categories of institutional and corporate members and the annual fees for all institutional and corporate members to be universally and invariably set at USD 1,000.

Upon approval from the 6th WeGO General Assembly, the New Membership Fee Criteria will take effect on members from 2024.
